Show Title: By the Hands of Women

By the Hands of Women is a celebration of women in the arts and the many ways creative work is shaped, guided, and transformed through lived experience, intuition, labor, and voice. Open to artists who identify as women, this exhibition invites participants to interpret the idea of “touched by a woman’s hand” in whatever way feels most authentic to their practice. Medium, style, and subject matter are entirely at the artist’s discretion, allowing for a wide and dynamic range of artistic responses.

The phrase *by the hand of women* may be interpreted literally, metaphorically, emotionally, or poetically. It can reference process, care, resilience, identity, lineage, protest, beauty, strength, or quiet observation. Artists are encouraged to explore what it means for something to be shaped, influenced, or brought into being through a woman’s perspective and presence.

This exhibition also honors the legacy of duCret’s founder, Marjorie Van Emburgh, whose commitment to arts education and advocacy for women artists helped establish a lasting creative community. In the spirit of her vision and in celebration of our **100th year** in Plainfield, *By the Hand of Women* seeks to amplify women’s voices across disciplines and celebrate the enduring impact of women as makers, thinkers, and cultural contributors.

Eligibility & Submission Guidelines:

- Open to all artists 18 years and older who identify as a woman.
- Artwork must be original in concept & creation.
- Artwork in 2D and 3D media will be considered for acceptance including photography, sculpture, needlework, and fiber arts.
- 2D work must be wired for hanging and ready for installation. Photography must be framed and wired for hanging.
- Sawtooth hangers will not be accepted.
- Work should not exceed 40” in height and 40” in width.
- 3D work must be able to stand-alone on the floor or on a pedestal, and if hanging it must not be more than 30lbs.

Pricing & Commission structure:

- All pieces in the show will be for sale unless otherwise decided by the artist.
- Please include a price in the submission form. If you would like your piece to be labeled Not For Sale, please type NFS in the price prompt.
- For any artwork sold during the exhibition, the **artist will receive 70% of the sale price, with the duCret Center of Art receiving a 30% commission.**
- Artists are encouraged to factor this commission into their pricing when submitting their work. The price you set should reflect both the value of your artwork and the commission structure.
- Artists will receive payment for works sold at the end of the show.

• **Notification of acceptance:** February 20th, 2026

• **Accepted works drop-off deadline:** Monday, February 24, 2025

• **Exhibition on view:** March 1-March 30
